

Report of Multilinks kick-off meeting and of the first meeting with the Multilinks Scientific Advisory Board (Deliverables D8.1 and D8.3)

The kick-off meeting of the EC-funded Multilinks research project *How demographic changes* shape intergenerational solidarity, well-being, and social integration: A multilinks framework (Grant agreement no. 217523, Seventh Framework Programme SSH-2007-3.1.1) was held in The Hague, April 16-17, 2008. The kick-off meeting also served as the first meeting with the Multilinks Scientific Advisory Board. The list of participants, and the programme of the meeting are **enclosed**.

The primary purpose of the kick-off meeting was to discuss the position papers prepared by researchers from each of the participating institutes. Topics of the position papers were:

- Intergenerational care regime indicators (Chiara Saraceno and Wolfgang Keck, Wissenschaftszentrum Berlin)
- Living arrangements and intergenerational support (Dimitri Mortelmans and Inge Pasteels, Antwerp University)
- Potential and actual support (Kalev Katus and Allan Puur, Estonian Interuniversity Population Research Centre)
- Intergenerational transfers and social inequality (Arnstein Aasve, Bocconi University)
- Values, gender and intergenerational solidarity (Britt Slagsvold, Gunhild Hagestand and Katharina Herlofson, Norwegian Social Research)
- Conceptualizations of support (Aafke Komter and Nienke Moor, Utrecht University)
- Welfare regimes and family solidarity (Niels Schenk and Pearl Dykstra, Netherlands Interdisciplinary Demographic Institute)
- Divorce and intergenerational exchanges (Jan van Bavel and Belinda Wijckmans, Free University Brussels).

Each of the position papers addressed the following questions:

- What do we, what do we not know about the topic
- Why does the topic matter
- How do we plan to contribute to the literature
- How will our work help answer the questions of Multilinks
- What is our curiosity regarding the topic.

Secondary purposes of the kick-off meeting were to:

- More fully acknowledge the policy relevance of the Multinks program
- Arrive at a list of members for the Policy Advisory Board (see the **enclosed** list)
- Be informed about contacts with and responsibilities towards the European Commission.

The meeting was characterized by lively scientific debates on the best ways of performing cross-national analyses, intergenerational segregation versus integration, the universality of solidarity models, and so forth. The two members of the Scientific Advisory Board who were able to attend the meeting provided constructive and critical feedback.
